We create an ecosystem whereby start-ups can connect easily with resources they need at early stages, thus attracting start-ups to this region. This supports growth in the companies themselves, the direct support services and in the region's economy as a whole, creating a virtuous cycle of economic growth. Assisted 182 innovation start-ups which currently employ 601 FTE.
